- Create a secure area for poisons such as locked cabinets, high cabinets/shelves, child safety locks
- install carbon monoxide detectors in your home
- Ingest medicine out of sight of children
- If you can't eat or drink it, don't place it in the refrigerator
- keep all medicines and potential poisonous substance in locked cabinets.
- Keep all medicines, and potentially poisonous substances, in locked cabinets or out of the reach of children.
- anything can be poisonous in excessive amounts

- Have a working Carbon Monoxide detector in your home.
- Anything can be poisonous in excessive amounts.
- Poisons can be used safely. Read the label and always follow directions on the package.
- Household cleaners, Medications, Cosmetics and personal care products, Foreign bodies (coins, watch batteries) Plants, berries and mushrooms are the top five most common everyday items ingested by children.
- If you can't eat it or drink it, don't place it in the refrigerator
- Keep poisons far away from food and drink
- Keep harmful substances out of reach.
- Keep toxic products on high shelf's out of children's reach
- Anything can poisonous in excessive amounts
- keep the medication cabinet locked at all the time
- do not store medicines, cleaning products or chemicals near food
- Be Prepared.
- If you start to feel sick, dizzy, weak, or have a bad headache while using a generator, get to fresh air immediately. Install battery-operated or plug-in CO alarms with batter back up in your home when using generators.
- Poison could be stored safely.
- Keep locked up away from children
- Take medicine where children can't observe. Children learn by imitation.
- Keep things out of reach
- Safe storage of all poisons

- Avoid using mercury thermometers
- never leave poisons unattended if children are nearby
- Don't leave prescriptions on the counter where children can get them should be in cabinet out of the reach of children
- Avoid using glass mercury thermometers.
- Store household products out of children's reach.
- Program the number for the poison center on your telephone
- Household products become potentially harmful when splashed in the eye, in the mouth or on the skin!
- Keep all medication in licked cabinets
- Children who taste products meant to kill mice or rats usually don't get sick. Most of these poisons "thin" the mouse's blood, causing bleeding. But large amounts or repeated nibbling are required to make a child sick.
- Always read package instructions
- Child proof cabinets, do not leave cleaning or laundry supplies within reach.
- It's free and confidential to talk to a poison control expert.
- Read the label.

- Store poisons in cabinets away from food and drink.
- Conduct a room-by-room survey for hazards.
